

Instructions for Transfers of Securities

Thank you so much for your interest in donating to Village Church by transferring securities.

On the 2nd page of this document, you will find a “Letter of Direction”. This serves to instruct your Financial Advisor / Brokerage Firm to transfer the specified number of shares from company X to Village Church.

For example, you would instruct your investment firm to transfer, on your behalf, from your account #1234-5678, 500 shares of XYZ Corp to Village Church, #4JCWA0A, held at IPC Securities Corp, 15300 Croydon Drive, 3rd Floor, Surrey, BC V3Z 0Z5.

A donation receipt will be generated for the value of the closing price of the securities, on the day the securities are received by IPC Securities Corp on behalf of Village Church. Receipts are emailed before the end of February for the previous year.

Please contact me when you have given your “Transfer of Securities” instructions to your Financial Advisor / Brokerage Firm. This will ensure we can follow up with Carey Vandenberg of IPC Securities Corp who handles Village Church’s donations of securities.
